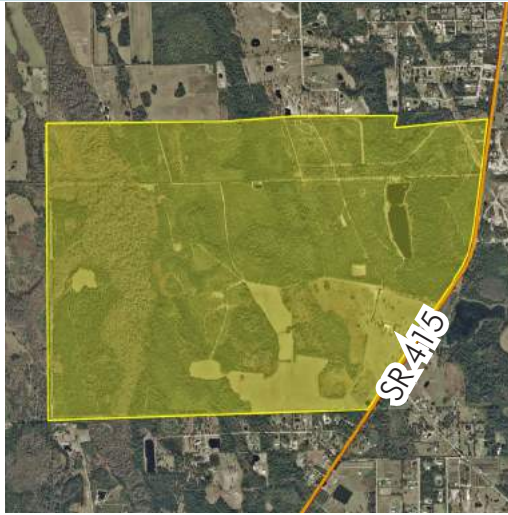

Hwy 415, a major arterial corridor servicing the area, is being expanded to four lanes. Project completion is expected for Fall of 2015.

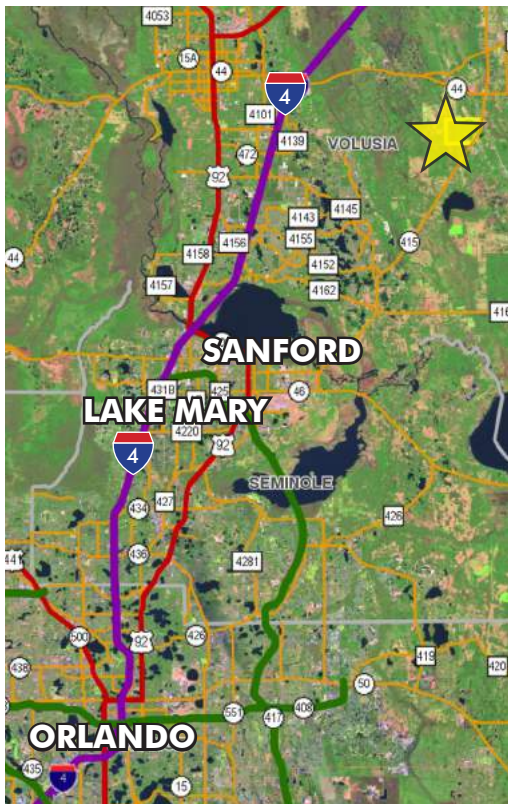

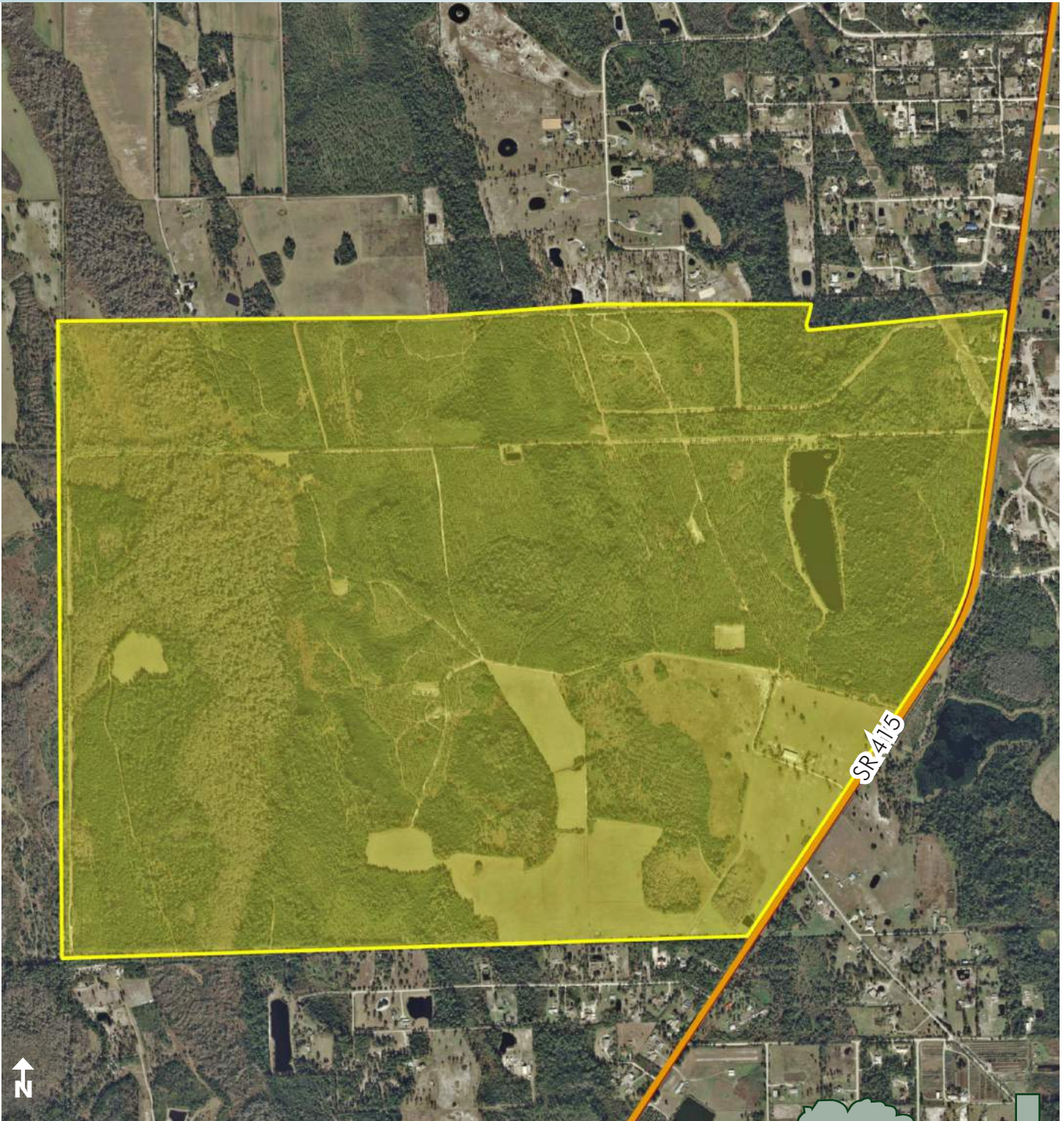

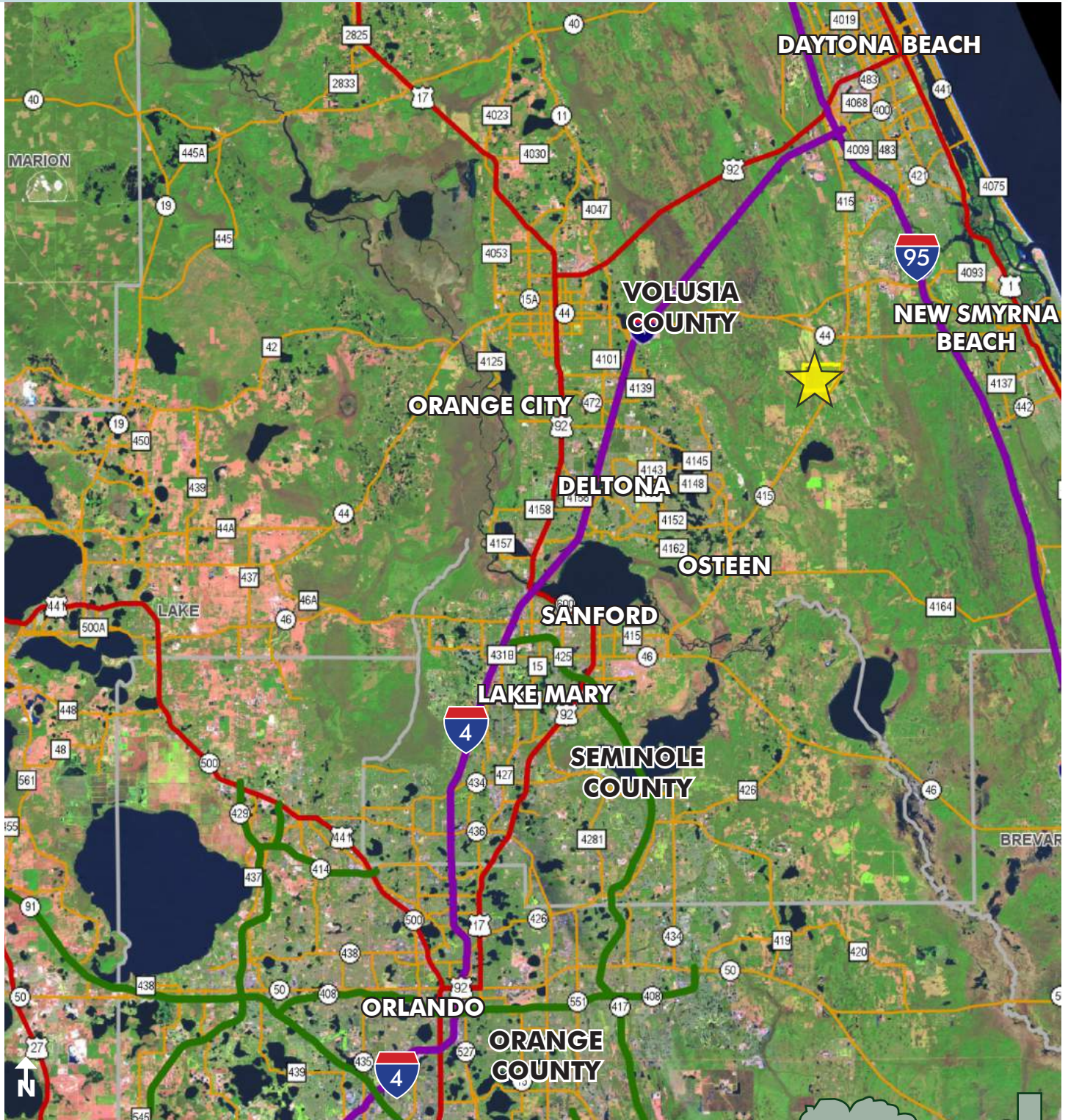
