

River Bend Ranch Reserve is an *Elite Central Florida Trophy Ranch*. This property is one of the last remaining (large acreage tracts) with significant river frontage on the St. Johns River. This property offers spectacular hunting, fishing, recreational and agricultural opportunities. Deer are plentiful and have been managed for size and health over the last several years. In addition, this property is teeming with Osceola Turkey - a turkey hunter's dream! Boar hogs, Florida Black Bears and other diverse wildlife call this property home.

Breathtaking Old Florida landscapes call this ranch home. Ancient Oak Hammocks, flatwood pine scrub and prairie land provide a treasure of Florida ecological beauty. Many parts of the ranch remain as natural as the day God created this land.

LOCATION

This property is centrally located, so accessing the ranch from anywhere in Central Florida is effortless. I-95 and other major roadways are all located in close proximity to River Bend Ranch Reserve.

River Bend Ranch Reserve is located just 30 minutes from New Smyrna, Titusville and

Daytona. Enjoy beaches, sunshine, dining, water sports, space craft launches, employment hubs, fishing and more.

Double Frontage! River Bend Ranch Reserve boasts 2+ miles of river frontage on the historic St. Johns River. Endless fishing, boating and water recreational opportunities exist on River Bend Ranch Reserve. Lake Harney is two miles directly to the south, fully accessible by boat via the St Johns River.

In today's day and age, this much river frontage is nearly unheard of on a major river, particularly on the St. Johns River. In the late 80s and early 90s, various governmental agencies (SJRWMD, Counties, State of Florida, and others) committed to purchasing nearly all of the land abutting and fronting the St. Johns River. This was all in the name of conservation and future stewardship of Florida's land and water resources. In this region, these entities have mostly succeeded in their plan to buy all large acreage ranches and timberlands with direct frontage on the St. Johns River. Only a few large pieces remain in this region with large river frontage and access. River Bend Ranch Reserve has maintained its status as one of the last private, large acreage tracts with significant river frontage, making this an exquisite and rare opportunity.

What's better than one major waterway located on an elite property? Having two! Deep Creek directly borders and flows south to the river on the northeastern portion of this property (see map). Deep Creek connects to the St. Johns River. Small boats can be used to enjoy Deep Creek and all it has to offer. Deep Creek is a beautiful additional waterway that gives River Bend Ranch Reserve another 1.3 miles of waterway frontage (see photos).
